2017 GOLF MEMBERSHIP PACKAGES

DEERHURST PLATINUM GOLF MEMBERSHIP \$3,100

- *Deerhurst Platinum Golf Members* may play both the Deerhurst Lakeside and Deerhurst Highlands
- Playing privileges are anytime 7 days a week and include access to club and social events at both courses
- Bookings may be made within 14 days of desired tee time
- *Deerhurst Platinum Golf Members* includes Golf Association of Ontario membership and bag storage at either facility
- Members have an unlimited seasonal cart package for both golf courses
- Unlimited access to the Lakeside Academy driving range

DEERHURST GOLD GOLF MEMBERSHIP HIGHLANDS \$2,800/ LAKESIDE \$1,400

- Playing privileges are anytime 7 days a week, and include access to club and social events at the chosen course
- Bookings may be made within 14 days of desired tee time
- *Deerhurst Gold Membership* includes Golf Association of Ontario membership
- Members have an unlimited seasonal cart package at your chosen course
- Highlands Gold members have unlimited access to the Lakeside Academy driving range

DEERHURST GOLD INTERMEDIATE (19 – 34) GOLF MEMBERSHIP HIGHLANDS \$1,400/ LAKESIDE \$700

- Playing privileges are anytime 7 days a week, and include access to club and social events at the chosen course
- Bookings may be made within 14 days of desired tee time
- *Deerhurst Gold Intermediate Membership* includes Golf Association of Ontario membership
- Members have an unlimited seasonal cart package at your chosen course

DEERHURST TWILIGHT GOLF MEMBERSHIP HIGHLANDS \$1,400/ LAKESIDE \$700

- *Deerhurst Twilight Golf Members* choose one course for play and may play any day during twilight golf hours.
- Bookings may be made within 14 days of desired twilight tee time
- *Deerhurst Twilight Gold Membership* does not include Golf Association of Ontario membership.
- Members have an unlimited seasonal twilight cart package.

DEERHURST LAKESIDE JUNIOR GOLF MEMBERSHIP (9yrs – 18yrs) \$250

- Supervised Clubhouse/Academy in July and August, Monday to Friday
- Playing privileges are anytime 7 days a week & bookings may be made within 7 days of desired tee time
- Members have an unlimited access to the Lakeside Academy driving range
- ***Juniors and parents must meet with Deerhurst Professional Staff prior to the season***

DEERHURST/HORSESHOE CORPORATE GOLF MEMBERSHIP \$3,100

- The *Deerhurst/Horseshoe Corporate Golf Membership* is permitted to play their choice of Deerhurst Lakeside, Deerhurst Highlands, and Horseshoe Valley under each Corporate Golf Membership
- The Corporate membership is transferable to any employee within the business or designate assigned by the principal
- The Corporate membership card must be presented at the golf shop
- The resale of the membership access is strictly prohibited
- Playing privileges are anytime 7 days a week
- Bookings may be made within 14 days of desired tee time
- Members have an unlimited access to the Lakeside Academy driving range
- Members have an unlimited seasonal cart package at any course

2017 MEMBERSHIP BENEFITS

RECIPROCAL PLAY AT DEERHURST & HORSESHOE RESORT

Tee-times are based upon availability and must be arranged with the Head Professional no earlier than 7 days in advance. Member reciprocal play is based on own course membership access, i.e. Twilight members have twilight reciprocal access only. Reciprocal play rate is not applicable for members' guests.

Deerhurst Lakeside members may play the Deerhurst Highlands course at the member guest fee
Deerhurst Highlands members may play the Deerhurst Lakeside course for cart fee only

Horseshoe Valley \$35 including cart, plus applicable tax

FULL SEASON GOLF BAG STORAGE

Club cleaning and storage for members' golf equipment is available: \$110 per season (either course)

MEMBER'S GUEST RATES

Tee times are based upon availability and must be booked by the member no earlier than 14 days in advance. Members may bring up to 7 guests at a time at the Member's Guest Rate. Any member who has more than 7 guests can make arrangements through the Head Golf Professional. Cart fee included at Highlands only, HST not included.

Open – June 18th (Mon-Sunday)

Deerhurst Highlands Member's Guest Rate: \$55 before twilight, \$35 after twilight

Deerhurst Lakeside Member's Guest Rate: \$23 before twilight, \$14 after twilight

June 19th – September 17th (Mon-Sunday)

Deerhurst Highlands Member's Guest Rate: \$90 before twilight, \$70 after twilight

Deerhurst Lakeside Member's Guest Rate: \$29 before twilight, \$17 after twilight

September 18th – Close (Mon-Sunday)

Deerhurst Highlands Member's Guest Rate: \$55 before twilight, \$35 after twilight

Deerhurst Lakeside Member's Guest Rate: \$23 before twilight, \$14 after twilight

Member's Junior Guests (18 & under)

Deerhurst Highlands - one junior free per member 1:1 ratio, \$50 anytime

Deerhurst Lakeside – one junior free per member 1:1 ratio, any additional juniors \$30 anytime
