- Membership will be limited to 100 members only.

- There is no equitable value or additional initiation fee to this membership year over year. As an accepted legacy member, you are entitled to purchase a membership or reassign it on a yearly basis. (Memberships cannot be reassigned with any monetary exchange or transaction of value; it that is determined then the membership will be revoked.)
- The legacy membership will be the only prepaid membership program at Deerhurst. All other course play will be through pay-as-you-play green fees. (Periodic pre-paid green fee specials or limited bundle purchases may be offered from time to time but are not guaranteed.)
- This membership will introduce new charging privileges for purchases at the golf course or clubhouse to be paid monthly, with no social minimums required.

- This membership will include all past perks including:
 - Preferred Member dining discounts for regular menus at resort restaurants
 - Access to the resort’s pool and fitness room year-round
 - 20% discount on Amba Spa at Deerhurst services
 - Member’s guest green fee discounts
 - Access to Deerhurst Lakeside driving range
 - Daily access to the course, with advanced tee time booking window
- Legacy membership dues will be \$2900 plus tax annually and will not go up in price except to keep up with the Consumer Price Index (CPI)
- This membership will be paid on an annual basis on March 15th of every year going forward
- An application program will be in place should our maximum not be achieved through existing accepted members
